Pursuant to the request made by the Applicant, we have completed our review of the above referenced site to determine if the performance bond (\$20,790.00 reduced amount) can be released for Faith Tabernacle Church. Based on the findings of our observations, we are informing the Borough that the work under this project has been completed, corrected and/or repaired.

As such, we would recommend that Borough consider the release of the water & sewer improvements performance bond. The Borough of Clayton requires that the Applicant post a two (2) year maintenance bond in the amount of 15% of the original water & sewer improvements performance bond. However, it should be noted that the water & sewer improvements have been in place for approximately a two (2) year period. As such, we would recommend that Council consider the release of the performance bond in the amount of \$20,790.00 (reduced amount) along with the waiving of the required maintenance bond.

It should be noted that prior to the release of the performance bond, all outstanding engineering fees must be paid in full. By copy of this letter to Christine Newcomb, Borough Clerk, we are requesting that this matter be placed on the agenda for approval at the next available Mayor & Council meeting.
