#### **ORDINANCE 20-2021**

# AN ORDINANCE AMENDING CHAPTER 21, ARTICLE 1 OF THE CODE OF THE BOROUGH OF CLAYTON

**BE IT ORDAINED** by the Mayor and Council of the Borough of Clayton, County of Gloucester and State of New Jersey that Chapter 21, Article I, Section 1 is hereby amended as set forth herein.

#### Section I. Amendment to Section 21-1.

Section 21-1, presently entitled "Department created; membership", shall be amended to include the underlined language below. The updated Code will not include the actual underline formatting.

Section 21-12. Department created; membership.

There is hereby created in and for the Borough of Clayton a Police Department which shall consist of a Chief of Police and such number of police officers and others that shall from time to time be deemed necessary by the Borough Council which shall, from time to time, determine the number of persons, including temporary officers and members in an emergency, to be appointed to these positions, together with their compensation. The positions authorized, with the maximum authorized number of positions for each, are that of Chief of Police (1), Acting Chief of Police (1), Captain (1), Lieutenant (2), Sergeant (6), Corporal (4), Patrol Officer (15), and Special Officers (6). The order of rank shall be in descending order: Chief of Police, Captain, Lieutenant, Sergeant, Corporal, Patrol Officer, and Special Officers. All positions hereby created need not be filled at all times, but only as deemed necessary by the Borough Council, within the municipal budget limitations.

#### Section II. Repealer

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies.

### Section III. Severability

Each section of this Ordinance is an independent section, and the holding of any section or part thereof to be unconstitutional, void or ineffective, shall not be deemed to affect the validity or constitutionality of any other sections or parts hereof.

**BE IT FURTHER ORDAINED** that this Ordinance shall take effect immediately upon final passage and publication as required by law.
