**ORDINANCE AMENDING BOND ORDINANCE 2014-8 OF
THE BOROUGH OF CLAYTON, COUNTY OF
GLOUCESTER, NEW JERSEY**

BACKGROUND

WHEREAS, the Borough of Clayton, County of Gloucester, New Jersey ("Borough"), duly and finally adopted Bond Ordinance 2014-8 ("Bond Ordinance"), authorizing the acquisition of various capital equipment and the completion of various capital improvements; and

WHEREAS, the Borough desires to amend certain project descriptions set forth in Section 7 of the Bond Ordinance.

NOW, THEREFORE, BE IT ORDAINED, BY THE BOROUGH COUNCIL (NOT LESS THAN TWO-THIRDS OF ALL THE MEMBERS THEREOF AFFIRMATIVELY CONCURRING), PURSUANT TO THE PROVISIONS OF THE LOCAL BOND LAW, CHAPTER 169 OF THE LAWS OF 1960 OF THE STATE OF NEW JERSEY, AS AMENDED AND SUPPLEMENTED ("LOCAL BOND LAW"), AS FOLLOWS:

Section 1. Section 7. of the Bond Ordinance is hereby amended to provide as follows:

"Section 7. The improvements hereby authorized and the purposes for which said obligations are to be issued; the estimated costs of each said purpose; the amount of down payment for each said purpose; the maximum amount obligations to be issued for each said purpose and the period of usefulness of each said purpose within the limitations of the Local Bond Law are as follows:

B.	Acquisition of an All Wheel Drive Vehicle for the Police Department, together with the acquisition of all materials and equipment and completion of all work necessary therefor or related thereto	41,000	2,050	38,950	5 years

C.	Acquisition of Various Equipment for the Public Works Department including, but not limited to, a Generator and Utility Truck, together with the acquisition of all materials and equipment and completion of all work necessary therefor or related thereto	87,000	4,350	82,650	5 years
D.	Acquisition of Various Equipment including, but not limited to Rescue Equipment, Cutter and Spreader, together with the acquisition of all materials and equipment and completion of all work necessary therefor or related thereto	16,500	825	15,675	5 years
E.	Environmental Investigation and/or Site Remediation at Block 1210, Lot 11, together with the acquisition of all materials and equipment and completion of all work necessary therefor or related thereto	45,000	2,250	42,750	5 years
F.	Acquisition of a Shuttle Bus, together with the acquisition of all materials and equipment and completion of all work necessary therefor or related thereto	50,000	2,500	47,500	5 years

Section 2. The capital budget is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency therewith and the regulations promulgated by the Local Finance Board showing full detail the amended capital budget and capital improvement program as approved by the Director of the Division of Local Government Services, New Jersey Department of Community Affairs, are on file with the Borough Clerk and available for public inspection.

Section 3. All other parts of the Bond Ordinance not amended hereby shall remain in full force and effect.

Section 4. In accordance with the Local Bond Law, this ordinance shall take effect twenty (20) days after the first publication thereof after final passage.
