ORDINANCE 22-2015

AN ORDINANCE AMENDING CHAPTER 93 OF THE CODE OF THE BOROUGH OF CLAYTON (WATER)

BE IT ORDAINED by the Mayor and Council of the Borough of Clayton as

follows:

Section 2. Chapter 93, Section 35(A) and (B) is hereby amended to read as follows:

93-35. Minimum meter charges.

A. The quarterly charges for all water passing through all meters shall be as follows:

First 7,000 Gallons	\$37.00
7,001 to 30,000 Gallons	3.28
30,001 to 40,000 Gallons	3.55
40,001 to 60,000 Gallons	4.03
60,001 to 80,000 Gallons	4.72

First 7,000 Gallons	\$42.00
7,001 to 30,000 Gallons	3.26
30,001 to 40,000 Gallons	3.34
40,001 to 60,000 Gallons	3.45
60,001 to 80,000 Gallons	3.55
80,001 and above	3.60

B. Senior citizens, as defined by the rules and regulations of the New Jersey statutes setting forth senior citizen exemptions, shall pay \$16.95 per quarter on a three-fourths-inch meter for up to 7,000 gallons of water. Such senior citizens shall receive such rate upon their notifying the Borough of Clayton of their status as a qualifying senior citizen. This rate shall apply to dwellings only, and each senior citizen, including spouse regardless of spouse's age, shall be entitled to this rate for one dwelling only.

BE IT FURTHER ORDAINED that this Ordinance shall take effect immediately upon final passage and publication as required by law.
