ORDINANCE # 14-2016

AN ORDINANCE AMENDING BY-LAWS FOR THE CLAYTON SENIOR CITIZEN CENTER ADOPTED BY ORDINANCE 11-2016

WHEREAS, a Committee was established to create a set of By-Laws for the operation of the Clayton Senior Citizen Center; and

WHEREAS, the By-Laws for the Clayton Senior Citizen Center were adopted by Ordinance 11-2016 on April 14, 2016; and

WHEREAS, it has been determined that the Bylaws for the Clayton Senior Citizen Center needed to be revised; and

WHEREAS, the revisions to the Bylaws for the Clayton Senior Citizen Center have been presented to Mayor and Council; and

WHEREAS, the revisions made to the Bylaws for the Clayton Senior Citizen Center are in the public interest.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Borough of Clayton, in the County of Gloucester and State of New Jersey that, the Borough of Clayton does hereby approve amending the By-Laws for the Clayton Senior Citizen Center pursuant to the revisions as referenced below.

Section 1. Article III, Use of the Senior Citizen Center, Section 3.

Building Access #2 of the Bylaws is hereby amended to read as follows:

2. The main doors located at the front of the building shall be locked and unlocked by a specific Allen Wrench/Hex Key to allow the group utilizing the building to open the main doors to allow access to the building. The Allen Wrench/Hex Key and detailed instructions showing how to open and lock the main doors will be located by the main doors. All doors must be locked when the group has finished using the building and is exiting the premises.

Section 2. Article III, Use of the Senior Citizen Center, Section 3.

Building Access #3 of the Bylaws is hereby amended to read as follows:

3. Keys for the toilet paper dispensers and soap dispensers located in the bathrooms shall be clearly marked and kept in the kitchen area.

Section 3. Article III, Use of the Senior Citizen Center, Section 6.

Miscellaneous Provisions of the Bylaws is hereby amended to read as follows:

1. From time to time, a situation may present itself wherein the Borough may have to utilize the Senior Citizen Center Building, for example, for use as a polling location for the annual Primary and General Elections. In the event the Borough needs to use/access the Senior Citizen Center Building for an event/activity as determined necessary by the Borough Council, then the Borough's use of the building shall take precedent on that particular day and time. The Borough will make every reasonable effort to avoid using the Senior Citizen Center Building on days where events/activities are previously scheduled. The Borough will provide adequate notice to any group(s) which may be impacted by its use of the Senior Citizen Center Building under these circumstances; and

BE IT FURTHER ORDAINED that this Ordinance shall take effect immediately upon final passage and publication as required by law.
