# ORDINANCE OF THE BOROUGH OF CLAYTON, COUNTY OF GLOUCESTER, NEW JERSEY CANCELING CERTAIN UNFUNDED APPROPRIATION BALANCES

#### **BACKGROUND**

WHEREAS, the Borough of Clayton, County of Gloucester, New Jersey ("Borough") duly and finally adopted the Bond Ordinances listed below in Section 1 (collectively, the "Bond Ordinances"); and

WHEREAS, the Borough is desirous of canceling certain unfunded appropriation balances.

**NOW, THEREFORE, BE IT ORDAINED** by the Borough Council (not less than two-thirds of all the members thereof affirmatively concurring), pursuant to the provisions of the Local Bond Law, constituting Chapter 169 of the Laws of 1960 of the State of New Jersey, as amended and supplemented ("Local Bond Law"), as follows:

**Section 1.** The following appropriations remain as a balance in the Bond Ordinances and are hereby cancelled:
