

ORDINANCE 2-2017

**AN ORDINANCE AMENDING CHAPTER 2, ADMINISTRATOR, OF THE CODE OF THE
BOROUGH OF CLAYTON**

BE IT ORDAINED by the Mayor and Council of the Borough of Clayton, County of Gloucester and State of New Jersey that Chapter 2 is hereby amended by adding a new subsection to read as follows:

Section I. Chapter 2, Administrator, is hereby amended by adding a new subsection to create the position of Assistant Borough Administrator to read as follows:

1. Assistant Borough Administrator:
 - A. There is hereby created in the Borough of Clayton the office of the Assistant Borough Administrator, and the title of said office shall be "Assistant Borough Administrator of the Borough of Clayton".
 - B. The Assistant Borough Administrator shall perform the duties of the office of Borough Administrator in the absence of the Borough Administrator or upon a vacancy in the office of the Borough Administrator or upon the disability of the Borough Administrator and shall perform such other duties and responsibilities as directed by the Borough Administrator.
 - C. The Assistant Borough Administrator may continue to hold and perform the duties of another Borough office.
 - D. The Assistant Borough Administrator shall be appointed by the Mayor with the advice and consent of the Council and shall be subject to all other applicable provisions of Chapter 2 of the Code of the Borough of Clayton.
 - E. Any salary to be paid to the Assistant Borough Administrator shall be

fixed in the annual Salary Ordinance. He/she will be reimbursed for necessary expenses incurred in the performance of the office.

F. The Assistant Borough Administrator shall be appointed on the basis of his/her executive and administrative qualifications.

G. The Assistant Borough Administrator need not be a resident of the Borough of Clayton.

Section 2. Repealer

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies.

Section 3. Severability

Each section of this Ordinance is an independent section, and the holding of any section or part thereof to be unconstitutional, void or ineffective, shall not be deemed to affect the validity or constitutionality of any other sections or parts hereof.

BE IT FURTHER ORDAINED that this Ordinance shall take effect immediately upon final passage and publication as required by law.
