

ORDINANCE 20-2017

ORDINANCE AUTHORIZING AN EMERGENCY APPROPRIATION N.J.S.A. 40A:4-53 FOR ENGAGEMENT OF SPECIAL CONSULTANTS FOR THE PREPARATION, AND THE PREPARATION OF A MASTER PLAN OR PLANS, WHEN REQUIRED IN ORDER TO CONFORM TO THE PLANNING LAWS OF THE STATE

BE IT ORDAINED by the Mayor and Council of the Borough of Clayton, in the County of Gloucester, New Jersey that pursuant to N.J.S.A. 40A:4-53 (Ch 48 P.L. 1956 as amended by Ch. 144, P.L. and Ch. 38, P.L. 1969), the sum of \$55,000.00 is hereby appropriated for the engagement of special consultants for the preparation, and the preparation of a master plan or plans, when required in order to conform to the planning laws of the State, and shall be deemed a special emergency appropriation as defined and provided for in N.J.S.A. 40A:4-55.

The authorization to finance the appropriation shall be provided for in succeeding annual budgets by the inclusion of at least 1/5 of the amount authorized pursuant to this act (N.J.S.A. 40A:4-55).

This Ordinance shall take effect after the first publication there after final adoption.
