

**ORDINANCE #25-2017**

**AN ORDINANCE AMENDING CHAPTER 89, ARTICLE XIII, SCHEDULES,  
SECTION 23, SCHEDULE I: NO PARKING, OF THE CODE OF THE  
BOROUGH OF CLAYTON  
(VEHICLES AND TRAFFIC)**

***BE IT ORDAINED*** by the Mayor and Council of the Borough of Clayton,  
County of Gloucester and State of New Jersey as follows:

**Section 1.** Chapter 89, Article XIII, Schedules, Section 23, Schedule I: No parking, is hereby amended by adding the following No Parking street location

<b>Name of Street</b>	<b>Side</b>	<b>Location</b>
Pop Kramer Blvd.	East	Entire length of the East side of the divider island.
Pop Kramer Blvd.	West	Entire length of the West side of the divider island.
Pop Kramer Blvd.	East	East side of ingress lane from Academy Street 60' to the North along the Blvd.
Pop Kramer Blvd.	West	West side of egress lane from Academy Street 180' to the North along the Blvd.
Pop Kramer Blvd.	East	East side of ingress lane within 50' from the northern terminus/stop sign where the ROW meets the School Board property.

**Section 2. Repealer**

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies.

**Section 4. Severability**

Each section of this Ordinance is an independent section, and the holding of any section or part thereof to be unconstitutional, void or ineffective, shall not be deemed to affect the validity or constitutionality of any other sections or parts hereof.

**BE IT FURTHER ORDAINED** that this Ordinance shall take effect immediately upon formal approval by the Clayton Borough Council and publication as required by law.
