AN ORDINANCE AMENDING THE BOROUGH OF CLAYTON'S PERSONNEL POLICIES AND PROCEDURES MANUAL SECTION TWO - WORKPLACE POLICIES TO ADD USE OF BOROUGH STATIONARY, OFFICE SUPPLIES AND OTHER OFFICE EQUIPMENT

WHEREAS, the Borough of Clayton has adopted a Personnel Policies and Procedures Manual ("Manual"); and

WHEREAS, the Manual is amended from time to time to address changes in policies and procedures applicable to employees of the Borough; and

WHEREAS, the Borough of Clayton desires to amend the Manual to include a new section related to the use of Borough stationary and office supplies.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Clayton, County of Gloucester, State of New Jersey that the governing body does hereby amend the Personnel Policies and Procedure Manual Section Two – Workplace Policies as follows:

Section 1. Section Two – Workplace Policies is hereby amending by adding a new section to be entitled "Use of Borough Stationary, Office Supplies and Other Equipment" to read as follows:

USE OF BOROUGH STATIONARY, OFFICE SUPPLIES, AND OTHER OFFICE EQUIPMENT

The Borough of Clayton provides stationary, postage, staplers, pens and other office supplies and equipment that are routinely used in conducting the business and operations of the Borough. While these office supplies and equipment are openly available for employees to use in carrying out their job duties and responsibilities, such office supplies and equipment are not to be used, by the employee(s) for personal use or non-Borough business. The use of Borough letterhead and Borough envelopes indicates the information delivered and contained within has been reviewed by, approved by, and/or authorized by the Borough and/or Borough management when received by the recipient(s). The Borough does recognize that office supplies and equipment are necessary for employees to perform daily tasks of their job duties and responsibilities.

Any employee using Borough stationary, office supplies and/or office equipment for any unapproved use will be subject to disciplinary action.

Section 2. Repealer

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies.

Section 3. Severability

Each section of this Ordinance is an independent section, and the holding of any section or part thereof to be unconstitutional, void or ineffective, shall not be deemed to affect the validity or constitutionality of any other sections or parts hereof.

BE IT FURTHER ORDAINED that this Ordinance shall take effect immediately upon final passage and publication as required by law.
