

ORDINANCE # 12-2018

**AN ORDINANCE AMENDING CHAPTER 69, PEDDLING AND SOLICITING,
ARTICLE 1, GENERAL REGULATIONS, SECTION 5 (C) AND SECTION 8 (D) OF
THE CODE OF THE BOROUGH OF CLAYTON (PEDDLING AND SOLICITING)**

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Borough of Clayton, County of Gloucester and State of New Jersey that the governing body does hereby amend Chapter 69 of the Code of the Borough of Clayton entitled Peddling and Soliciting as follows:

Section 1. Chapter 69, Article I, Section 5(C), is hereby amended to read as follows:

Upon receiving the application set forth above, the Borough Clerk or Chief of Police shall issue a license without charge to such organization, association, society, corporation, etc., for each of their or its representatives who will actually conduct the solicitations.

Section 2. Chapter 69, Article I, Section 8 (D), is hereby amended to read as follows:

The license issued hereunder shall be in the form of a badge and receipt for payment of the fee as set forth hereinafter.

Section 3. Repealer


All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies.

Section 4. Severability

Each section of this Ordinance is an independent section, and the holding of any section or part thereof to be unconstitutional, void or ineffective, shall not be deemed to affect the validity or constitutionality of any other sections or parts hereof.


BE IT FURTHER ORDAINED that this Ordinance shall take effect immediately upon formal approval by the Clayton Borough Council and publication as required by law.


