WHEREAS, the acceptance and recording of said Quitclaim Deed by the Borough of Clayton is in the public interest.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Borough of Clayton, in the County of Gloucester and State of New Jersey that, pursuant to Local Lands and Buildings Law of the State of New Jersey, N.J.S.A. 40A:12-1, et seq., the Borough of Clayton does hereby accept the conveyance of the aforementioned Quitclaim Deed, attached hereto, by Veterans of Foreign Wars, Department of New Jersey to the Borough of Clayton for property located at Block 203/Lot 1.

**BE IT FURTHER ORDAINED** that this Ordinance shall take effect immediately upon final passage and publication as required by law.
