AN ORDINANCE AMENDING CHAPTER 86A, TOWING AND STORAGE SERVICES, ARTICLE III, POLICE DEPARTMENT TOW LIST, SECTION 86A-10, GENERAL REQUIREMENTS, SUBSECTION C OF THE CODE OF THE BOROUGH OF CLAYTON

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Borough of Clayton, County of Gloucester and State of New Jersey that the governing body does hereby amend Chapter 86A of the Code of the Borough of Clayton entitled Towing and Storage Services as follows:

Section 1. Chapter 86A, Towing and Storage Services, Article III, Police Department Tow List, Section 86A-10, General Requirements, Subsection C is hereby amended to read as follows:

§86A-10(C) The list of licensed towing operators shall be maintained by the Police Department and shall be utilized on a rotation basis. The rotation shall be on a weekly basis beginning at 6:00 am Monday and ending one week later at 6:00 am Monday, unless otherwise specified by the Police Department or in the event of emergency conditions.

Section 2. Repealer

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies.

Section 3. Severability

Each section of this Ordinance is an independent section, and the holding of any section or part thereof to be unconstitutional, void or ineffective, shall not be deemed to affect the validity or constitutionality of any other sections or parts hereof.

BE IT FURTHER ORDAINED that this Ordinance shall take effect immediately upon formal approval by the Clayton Borough Council and publication as required by law.
