AN ORDINANCE AMENDING CHAPTER 1, GENERAL PROVISIONS, ARTICLE I. ENFORCEMENT; GENERAL PENALTY, SECTION 1-1, ENFORCING OFFICERS, OF THE CODE OF THE BOROUGH OF CLAYTON

BE IT ORDAINED by the Mayor and Council of the Borough of Clayton,
County of Gloucester and State of New Jersey as follows:

Section 1. Chapter 1, General Provisions, Article I. Enforcement; General Penalty, Section 1-1, Enforcing officers, is hereby amended to read as follows:

1. Unless otherwise regulated by statute or specifically identified by a particular ordinance, article, or section contained therein, the Enforcing Officers of the Borough Code shall be the Code Enforcement Officer, the Zoning Officer, Construction Code Official, Director of Public Works and Clayton Police Officers.

Section 2. Repealer

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies.

Section 3. Severability

Each section of this Ordinance is an independent section, and the holding of any section or part thereof to be unconstitutional, void or ineffective, shall not be deemed to affect the validity or constitutionality of any other sections or parts hereof.

BE IT FURTHER ORDAINED that this Ordinance shall take effect immediately upon formal approval by the Clayton Borough Council and publication as required by law.
