#### **ORDINANCE 4-2021**

## AN ORDINANCE AMENDING CHAPTER 93 OF THE CODE OF THE BOROUGH OF CLAYTON (WATER)

**BE IT ORDAINED** by the Mayor and Council of the Borough of Clayton as

follows:

Section 1. Chapter 93, Section 35(A) and (B) is hereby amended to read as

follows:

### 93-35. Minimum meter charges.

A. The quarterly charges for all water passing through all meters shall be as follows:

B. Senior citizens, as defined by the rules and regulations of the New Jersey statutes setting forth senior citizen exemptions, shall pay \$18.30 per quarter on a three-fourths-inch meter for up to 7,000 gallons of water. Such senior citizens shall receive such rate upon their notifying the Borough of Clayton of their status as a qualifying senior citizen. This rate shall apply to dwellings only, and each senior citizen, including spouse regardless of spouse's age, shall be entitled to this rate for one dwelling only.

Section 2. Article II, Chapter 93, Section 93-16 (B)(1)(a) and (b)is hereby amended to read as follows:
