COUNTY OF GLOUCESTER, NEW JERSEY,
APPROPRIATING \$23,000 FOR IMPROVEMENTS TO
CLAYTON'S SEWER COLLECTION SYSTEM AT 253 N.
DENNIS DRIVE**

**BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF
CLAYTON, COUNTY OF GLOUCESTER, STATE OF NEW JERSEY, AS FOLLOWS:**

Section 1. There is hereby appropriated the sum of \$23,000 from the Water/Sewer Capital Improvement Fund for improvements to the Sewer Collection System at 253 N. Dennis Drive, together with the acquisition of all materials and equipment and completion of all work necessary therefore or related thereto, all as further described in the information on file and available for inspection in the offices of the Borough Clerk (collectively, the "Project").

Section 2. It is hereby determined and stated that the Project set forth in Section 1 is a utility improvement and is not a current expense of the Borough.

Section 3. The capital budget is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency therewith, and the resolution promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services, is on file with the Borough Clerk and available for inspection.

Section 4. All ordinances, or parts of ordinances, inconsistent herewith are hereby repealed to the extent of such inconsistency.

Section 5. This ordinance shall take effect after final adoption and publication as required by law.
