# AN ORDINANCE AMENDING CHAPTER 53, DOGS AND CATS, ARTICLE I, REGULATIONS, SECTION 53-5. B OF THE CODE OF THE BOROUGH OF CLAYTON (DOGS AND CATS)

**NOW, THEREFORE, BE IT ORDAINED,** by the Mayor and Council of the Borough of Clayton, County of Gloucester and State of New Jersey that the governing body does hereby amend Chapter 53 of the Code of the Borough of Clayton entitled Dogs and Cats as follows:

**Section 1.** Chapter 53, Dogs and Cats, Article I, Regulations. Section 53-5 B. Licensing and vaccination requirements; exemptions is hereby amended to read as follows:

53-5. B. All dogs and cats within the limits of the Borough of Clayton shall be licensed in accordance with New Jersey statutes in such case made, and the licensing fee therefore shall be \$8.20 per year for dogs and cats, except that all dogs and cats within the Borough limits qualifying for licensing on the first day of each year shall be licensed on or before March 31 of each year. The fee for licensing said dogs and cats subsequent to said date shall be \$12.20 per year.

#### Section 2. Repealer

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies.

### Section 3. Severability

Each section of this Ordinance is an independent section, and the holding of any section or part thereof to be unconstitutional, void or ineffective, shall not be deemed to affect the validity or constitutionality of any other sections or parts hereof.

**BE IT FURTHER ORDAINED** that this Ordinance shall take effect immediately upon formal approval by the Clayton Borough Council and publication as required by law.
