**BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF  
CLAYTON, COUNTY OF GLOUCESTER, STATE OF NEW JERSEY, AS FOLLOWS:**

**Section 1.** There is hereby appropriated the sum of \$33,400 from the Water & Sewer Capital Account for the Completion of Various Water and Sewer Utility Improvements including, but not limited to, the Repair of Water Mains at various locations and the Replacement of Air Release Valves and Pull Pumps, together with the acquisition of all materials and equipment and completion of all work necessary therefore or related thereto (collectively, the "Project").

**Section 2.** It is hereby determined and stated that the Project set forth in Section 1 is a capital improvement and is not a current expense of the Borough.

**Section 3.** The capital budget is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency therewith, and the resolution promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services, is on file with the Borough Clerk and available for inspection.

**Section 4.** All ordinances, or parts of ordinances, inconsistent herewith are hereby repealed to the extent of such inconsistency.

**Section 5.** This ordinance shall take effect after final adoption and publication as required by law.


