AN ORDINANCE AMENDING BY-LAWS FOR THE CLAYTON SENIOR CITIZEN CENTER ADOPTED BY ORDINANCE 11-2016

WHEREAS, a Committee was established to create a set of By-Laws for the operation of the Clayton Senior Citizen Center; and

WHEREAS, the By-Laws for the Clayton Senior Citizen Center were adopted by Ordinance 11-2016 on April 14, 2016; and

WHEREAS, the By-Laws for the Clayton Senior Citizen Center were amended by Ordinance 14-2016 on June 9, 2016; and

WHEREAS, the By-Laws for the Clayton Senior Citizen Center were again amended by Ordinance 15-2016 on July 14, 2016; and

WHEREAS, it has been determined that the Bylaws for the Clayton Senior Citizen Center needed to be revised; and

WHEREAS, the revisions to the Bylaws for the Clayton Senior Citizen Center have been presented to Mayor and Council; and

WHEREAS, the revisions made to the Bylaws for the Clayton Senior Citizen Center are in the public interest.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Borough of Clayton, in the County of Gloucester and State of New Jersey that, the Borough of Clayton does hereby approve amending the By-Laws for the Clayton Senior Citizen Center as follows.

Section 1. Article No. 2, Senior Center Committee. Section 2, Responsibilities of the Bylaws shall be amended to include a new subsection §8 to read as follows:

8. The Committee may draft policies and/or procedures regarding the

operation of the Senior Citizens Center and present such policies and/or procedures to the Borough Council for their consideration and approval. Borough Council shall have the right to amend the By-Laws and/or adopt policies and/or procedures at any time and as may be needed for the Senior Citizen Center.

Section 2. The Clayton Senior Citizen Center Bylaws and Regulations is

hereby amended to include Article 4 to read as follows:

Article No. 3 Amendments to Bylaws.

Bylaws and amendments to the Bylaws for the Clayton Senior Citizen Center shall be approved by Borough Council.

BE IT FURTHER ORDAINED that this Ordinance shall take effect immediately upon final passage and publication as required by law.
