Each such meeting of the Board shall commence at 7 p.m., time prevailing, and be held in the Borough of Clayton Municipal Building, 125 North Delsea Drive, Clayton, New Jersey, 08312, unless prior notice is given to the contrary, or at such other time, date or place as any such meeting shall be adjourned to, upon proper notice being given in accordance with law.
- 4. A copy of this resolution with attachment shall be forwarded to the Borough Clerk of the Borough of Clayton for posting in at least one (1) prominent location with the Borough whereby the public is able to take notice of the same.
- 5. The Secretary of the Board be directed to send a copy of the attached "Schedule of Public Meetings for the Year 2022 to the *The Sentinel of Gloucester County* and the *South Jersey Times* newspapers, the two (2) official newspapers designated by the Board, immediately after adoption hereof.
