**RESOLUTION AMENDING RESOLUTION #04-2020 SETTING FORTH A
SCHEDULE OF PUBLIC MEETINGS TO BE HELD BY THE COMBINED
PLANNING/ZONING BOARD OF ADJUSTMENT OF THE BOROUGH OF
CLAYTON, COUNTY OF GLOUCESTER, STATE OF NEW JERSEY, FOR THE
YEAR 2020**

WHEREAS, it becomes necessary for the proper and orderly functioning of the Combined Planning/Zoning Board of Adjustment of the Borough of Clayton, County of Gloucester, State of New Jersey (the "Board") to set forth and make known its schedule of meetings to be held during the calendar year 2020, including the Board's Reorganization Meeting for the year 2021; and

WHEREAS, state law in the form of the Open Public Meetings Act (N.J.S.A. 10:4-6 et seq.), otherwise known as the "Sunshine Law", requires that a public body within seven (7) days of its annual Reorganization Meeting shall post and maintain a schedule of meetings to be held during the year; and

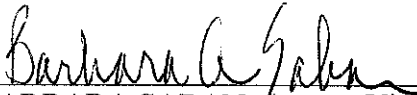
NOW, THEREFORE, BE IT RESOLVED, by the Combined Planning/Zoning Board of Adjustment of the Borough of Clayton, County of Gloucester, State of New Jersey, as follows:

1. All regular meetings of the Board to be held for the year 2020, and the Board's yearly 2021 Reorganization Meeting, shall be as set forth in the attached "Schedule of Public Meetings For The Year 2020".
2. Other special or rescheduled meetings or hearing shall be held at such time, date and location as provided for in accordance with applicable state law under the provisions of "adequate notice" which shall date, in addition to the immediately foregoing and to the extent known, the agenda of each such meeting and whether it is expected that formal action may or may not be taken at such meeting.
3. Each such meeting of the Board shall commence at 7:30 p.m., time prevailing, and be held in the Borough of Clayton Municipal Building, 125 North Delsea Drive, Clayton, New Jersey, 08312, unless prior notice is given to the contrary, or at such other time, date or place as any such meeting shall be adjourned to, upon proper notice being given in accordance with law.
4. A copy of this resolution with attachment shall be forwarded to the Borough Clerk of the Borough of Clayton for posting in at least one (1) prominent location with the Borough whereby the public is able to take notice of the same.
5. The Secretary of the Board be directed to send a copy of the attached "Schedule of Public Meetings for the Year 2020 to the *The Sentinel of Gloucester County*

and the *South Jersey Times* newspapers, the two (2) official newspapers designated by the Board, immediately after adoption hereof.

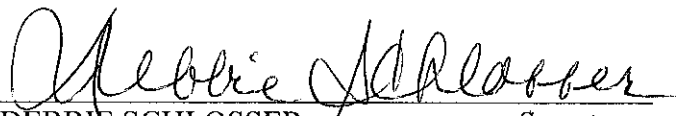
