**WHEREAS**, Julio and Maria Aviles (the "Applicants"), of 521 Coleman Drive, Clayton, New Jersey, 08312, also known as Block 2001.05, Lot 11, submitted an application for bulk variance relief for a backyard pergola and appeared before the Clayton Land Use Board (the "Board") on Monday, February 27, 2023; and

**WHEREAS**, on February 27, 2023, the Board approved the Application with certain conditions; and

**WHEREAS**, on March 27, 2023, the Board adopted Resolution No. 08-2023, memorializing the approval; and

**WHEREAS**, the Board was under the mistaken impression that the Uniform Construction Code ("UCC") requires any structure to be at least ten (10) feet from a swimming pool; and

**WHEREAS**, the Board has since learned that the UCC does not require such separation, and therefore finds it appropriate to amend Resolution No. 08-2023 to remove Condition 2, to correct the mistake.

**NOW, THEREFORE, BE IT RESOLVED** by the Borough of Clayton Planning Board, that Resolution No. 08-2023 is hereby amended, and Condition 2 is hereby removed.

**BE IT FURTHER RESOLVED**, that certified copies of this Resolution shall be forwarded to the Applicants, Borough Clerk, Borough Construction Official, Borough Tax Assessor, and the Borough Zoning Officer.
