**RESOLUTION OF THE BOROUGH OF CLAYTON LAND USE BOARD
CONFIRMING MASTER PLAN CONSISTENCY OF ORDINANCE NO. 4-2024**

WHEREAS, Section 26.a of the Municipal Land Use Law (N.J.S.A. 40:55D-26.a) requires the Governing Body, prior to the adoption of a land development regulation or revision or amendment thereto, to refer same to the Land Use Board for determination of whether the regulation, revision or amendment is consistent with the Master Plan; and

WHEREAS, the statute provides the Land Use Board 35 days from the date of referral to conduct its review and submit a report to the Governing Body setting forth its recommendations and determinations as to Master Plan consistency which the Governing Body must evaluate and consider prior to the final adoption of the development regulation; and

WHEREAS, the Council of the Borough of Clayton has referred to the Land Use Board proposed Ordinance No. 4-2024 for Master Plan consistency review pursuant to the aforementioned statute; and

WHEREAS, Ordinance No. 4-2024 adopts the New Jersey Department of Environmental Protection's ("NJDEP") updated stormwater management regulations; and

WHEREAS, on February 26, 2024, the Land Use Board reviewed the Ordinance; and

WHEREAS, the Board's Planner and Engineer, Wayne Roorda, PE, PP, CME, provided testimony on the Ordinance, and Mr. Roorda testified that Ordinance No. 4-2023 is consistent with the Master Plan and the 2017/2018 Master Plan Reexamination Report; and

WHEREAS, the Land Use Board found that the Ordinance will bring the Borough's stormwater management regulations into compliance with NJDEP requirements; and


WHEREAS, the Land Use Board has found and determined that Ordinance 4-2024 is consistent with the Master Plan and the 2017/2018 Master Plan Reexamination Report and made no recommendation for changes to the Ordinance prior to adoption.




