## RESOLUTION OF THE BOROUGH OF CLAYTON PLANNING BOARD GRANTING MINOR SUBDIVISION APPROVAL FOR BLOCK 1206, LOT 12

## APPLICANT - SOUTH JERSEY DEVELOPMENT CORP., LLC

WHEREAS, the Applicant, South Jersey Development Corp., LLC, of 783 Royal Avenue, Franklinville, New Jersey, submitted an application seeking approval of a minor subdivision with variances for land which is owned by the Applicant; and

WHEREAS, the property in question is shown on the Tax Map of the Borough of Clayton as Block 1206, Lot 12 and is located at the corner of East High Street and the intersection with North New Street; and

**WHEREAS**, the Applicant submitted a Proposed Minor Subdivision Plan dated October 11, 2013 and revised December 31, 2013, signed and sealed by Robert J. Monson, P.L.S., located in Williamstown, New Jersey; and

**WHEREAS**, the subject parcels are located in an R-C High Density Residential Zoning District which requires a minimum lot area of 6,000 square feet; and

**WHEREAS**, the subject application is in the form of a lot line adjustment to create Lot 12 comprising 7,920 square feet and proposed Lot 12.01 comprising 7,592 square feet; and

**WHEREAS**, each of the subject lots, i.e. Lot 12 and Lot 12.01, substantially conform to the R-C Zone standard with the following requested bulk variance relief: Lot 12 has 98.09 feet of lot depth where 100 feet is required and Lot 12.01 has 83.22 feet of lot depth where 100 feet is required; and

**WHEREAS**, the Subdivision Plan fails to show an existing dwelling on Lot 12, the Board was able to proceed to hear this matter as the plan may be conformed later to identify any existing structures; and

**BE IT FURTHER RESOLVED**, that certified copies of this Resolution shall be forwarded to the applicant, Borough Clerk, Borough Construction Official, Borough Tax Assessor, and the Borough Zoning Officer.
