- 2. That THE SENTINEL, P.O. Box 367, Franklinville, New Jersey 08322 is, and the same is hereby designated as, the second official newspaper of the Board for the calendar year 2015, and that said newspaper is to receive notices of meetings and such other matters as are required to be sent to a second newspaper under the Open Public Meetings Act.
