- 3. That Stan Bitacal of the firm of federical taking a licensed Professional Engineer in the State of New Jersey, be and the same is hereby appointed as Professional Engineer to the Board for the year 2016.

BE IT FURTHER RESOLVED that the Chairperson and the Secretary to the Board are hereby authorized to enter into and execute on behalf of the Board, contracts with the above named professional appointees, and that such contracts are awarded without competitive bidding as "Professional Services" under the provisions of the Local Public Contracts Law, because the aforesaid contracts encompass professional services

recognized, licensed and regulated by law, and that they are of a nature where it is not possible to obtain competitive bids; and

BE IT STILL FURTHER RESOLVED that notice of this award of contracts for professional services be published in the *South Jersey Times*, the officially designated newspaper of the Board for legal advertising, as required within ten (10) days of its passage.
