- 1. That *Kevin Nesko* be and is hereby elected as Chairperson of the Board for a term beginning January 1, 2017 and ending December 31, 2017.
- 2. That *Joe Abate* be and is hereby elected as Vice Chairperson of the Board for a term beginning January 1, 2017 and ending December 31, 2017.
- 3. That *Debbie Schlosser* be, and the same is hereby appointed as Secretary of the Board for a term beginning on January 1, 2017 and ending on December 31, 2017 and that, further, said Secretary shall be paid a salary in accordance with such agreements, terms and conditions as are entered into by and between the Board and said appointee for such purpose, pursuant to the applicable salary ordinance adopted by the Borough of Clayton for the year 2017.
- 4. That all monies collected for fees and escrows be given to the Borough's Treasurer and/or Chief Financial Officer for deposit into accounts of banks designated as official depositories of the Borough of Clayton by the Borough Council of the Borough of Clayton, and that the Borough Treasurer and/or Chief Financial Officer shall follows the required procedures in the handling of such fees and escrow as set forth in the Borough's ordinance(s) governing the same, as well as N.J.S.A. 40:55D-53.2, et seq.
- 5. That all official documents of the Board shall be properly identified and placed in the Board's file cabinet.
