**RESOLUTION DESIGNATING OFFICIAL NEWSPAPERS OF THE
COMBINED PLANNING/ZONING BOARD OF ADJUSTMENT OF THE
BOROUGH OF CLAYTON, COUNTY OF GLOUCESTER, STATE OF
NEW JERSEY, FOR THE YEAR 2018**

WHEREAS, it is necessary to designate the official newspapers of the Combined Planning/Zoning Board of Adjustment of the Borough of Clayton, County of Gloucester, State of New Jersey (the "Board"), in which publication of public notices, legal advertisements, notices of hearings, and such other official communications and/or information from, about, or pertaining to the Board, may be forthcoming, or as required to be published in accordance with law; and

WHEREAS, Section 3 of the Open Public Meetings Act, Chapter 231, P.L. 1975, requires that certain notices of meetings be submitted to one (1) newspaper, one of which shall be the official newspaper of the Board; and

WHEREAS, the second newspaper designated by the Board must be one which has the greatest likelihood, in addition to the official newspaper, of informing the public within the jurisdictional boundaries of the Board of such meetings;

NOW, THEREFORE, BE IT RESOLVED, by the Combined Planning/Zoning Board of Adjustment of the Borough of Clayton, County of Gloucester, State of New Jersey, as follows:

1. That the SOUTH JERSEY TIMES, 161 Bridgeton Pike, Suite E, Mullica Hill, New Jersey 08062 be and the same is hereby designated as the official newspaper of the Board for the year 2018.

2. That THE SENTINEL OF GLOUCESTER COUNTY, P.O. Box 367, Franklinville, New Jersey 08322 is, and the same is hereby designated as, the second official newspaper of the Board for the calendar year 2018, and that said newspaper is to receive notices of meetings and such other matters as are required to be sent to a second newspaper under the Open Public Meetings Act.

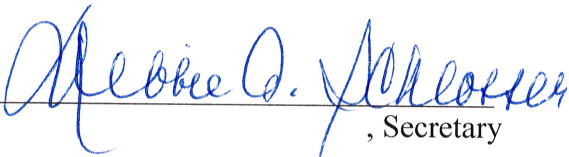
3. That THE CLAYTON FREE PRESS, P.O. BOX 201, Clayton, New Jersey 08312 is, and the same is hereby designated as, the third official newspaper of the Board for the calendar year 2018, and that said newspaper is to receive notices of meeting and such other matters as are required to be sent to a second newspaper under the Open Public Meetings Act.

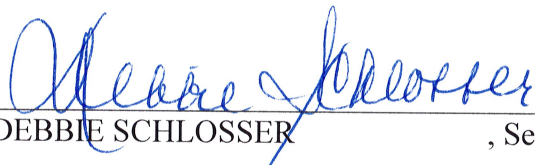
