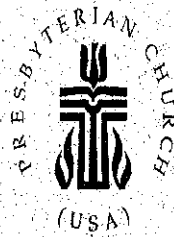

The First Presbyterian Church of Clayton together with the Clayton Elks Lodge No. 2132 is pleased to give you as part of our community outreach programs a Revolution Inclusive Spinner manufactured by Little Tikes Commercial of Monett, MO, for installation, operation, and maintenance by you in Sandelier Park. We are further pleased that this gift will comprise a part of Phase I of the Multi-Phase Plan being developed to enhance the accessibility and inclusiveness of the Park for all Borough residents.

As you know, the Borough has retained the engineering firm of Remington & Vernick ("RV") to advise the Borough with respect to complying with Americans with Disabilities Act requirements for Borough properties including the Park. When we expressed interest in providing funds for compliance equipment for Sandelier Park, you were kind enough to allow us to meet with both Borough personnel and persons from RV to identify what equipment would meet those criteria and be within the funds we had available for the gift. With RV's help and the Borough's concurrence, the decision settled on the Revolution Inclusive Spinner.

We especially appreciate that in a gracious effort to be "partners" with us in the project, the Borough has agreed not only to install the equipment, but also to install the appropriate ground material on the area surrounding the equipment and a pathway leading up to it to ensure that the equipment and its surroundings are suitable for use by persons with special needs. We also greatly appreciate that the Borough will see to the operation and maintenance of the Equipment.

We hope that this gift will prove both a boon for all of Clayton's residents and the "anchor" step for a Sandelier Park enjoyable by all. Kindly for our records, sign and return the enclosed copy of this letter to evidence acceptance of the gift and agreement with the understandings set out above.
