**RESOLUTION AWARDING CONTRACT FOR THE PURCHASE OF ONE (1)
2019 POLICE PATROL VEHICLE FOR THE CLAYTON POLICE
DEPARTMENT**

WHEREAS, there is a need to purchase one (1) 2019 Police Patrol Vehicle (Dodge Journey 4Dr SE FWD with upgrade to 3.6L V6 24V VVT Engine) for the Borough of Clayton, County of Gloucester, State of New Jersey; and

WHEREAS, this can be purchased through State Contract #A86922; and

WHEREAS, the amount of the purchase price is \$19,699.00 for the one (1) 2019 Police Patrol Vehicle (Dodge Journey 4Dr SE FWD with upgrade to 3.6L V6 24V VVT Engine); and

WHEREAS, Donna Nestore, Chief Financial Officer of the Borough of Clayton has certified that sufficient funds have been appropriated and are available to cover this contract. The funds are available by virtue of the Law Enforcement Trust Fund.

BE IT FURTHER RESOLVED that the Mayor and Clerk be and hereby are authorized to execute said Contract.


