RESOLUTION AUTHORIZING AGREEMENT FOR CERTAIN PROFESSIONAL SERVICES ADOPTED BY THE BOROUGH OF CLAYTON

- 5. A copy of this resolution as well as the Contract shall be placed on file with the Clerk of the Borough of Clayton.
- 6. A notice in accordance with the Local Public Contracts Law of New Jersey shall be published in The Sentinel or South Jersey Times.

Sickels & Associates, Inc. (herein referred to as S&A) would like to thank you for the opportunity to offer the services of our firm for the necessary engineering services on the above referenced project.

The use of LED fixtures will also reduce the electrical demand for the street lighting program and therefor lower the monthly costs to the Borough for same. The Borough has the desire to proceed with converting the existing high pressure sodium (hps) street lights to LED fixtures.

This proposal is for the submission of the LED street light conversions for the entire Municipality. Our office will review plans and spread sheets that will be utilized by Atlantic City Electric (ACE) for the installation of the new LED street lights. We understand the Borough has submitted a NJ Clean Energy Program application as to the replacement of the high pressure sodium (HPS) streetlights.

OUR UNDERSTANDING OF THE PROJECT

ACE will be providing the Borough plans and spread sheets that depict the locations, style, manufacturer and wattage of the new light fixtures for approximately 610 street lights. Our staff will review the maps to determine if the proposed wattage is adequate for the proposed locations. Our staff will forward any changes to the Borough and Tim Bateman at Atlantic City Electric for their consideration.

Based upon the amount of lights, we anticipate approximately 12 sets of ACE plans to be submitted over a several month period. Our staff will review each phase and submit our comments to the Boro and Ace for their consideration.

We recommend the Police Department staff provide comments as to any parts of the Borough that need improved lighting to determine if a large wattage fixture would be prudent for pedestrian safety. This will assist our review of the plans that will be provided by ACE. Any changes will be sent to ACE so that they can update their invoicing.

We understand the Borough will coordinate with ACE staff for billing information needed and complete the NJ Clean Energy Applications and spread sheet for each phase of work. We understand the Borough will submit the documentation to the NJ Clean Energy Program. The Borough will coordinate with the Program for any questions or additional information that arises during review of the application.

We understand the Borough has been informed the NJDOT will not require an application for replacement of street lights on State Highways.

SUPPLEMENTAL SERVICES

We believe our proposal as presented is comprehensive to satisfy the requirements of the project. However, if deemed necessary by the client or regulatory agencies, we will offer an addendum to perform these additional services.

CONSULTING FEE FOR SERVICES RENDERED

Based on the understanding of the project and description of service, our total consulting fee to complete the various activities described herein is estimated at \$ 7,760.00 plus the cost of applicable reimbursable expenses which will be invoiced separately.

Sickels & Associates is prepared to commence work immediately upon receipt of authorization to proceed. This proposal assumes that said authorization will be issued within sixty (60) days from the date of this proposal. The terms and conditions of this proposal shall remain in effect for sixty (60) days.
