**RESOLUTION AUTHORIZING AGREEMENT FOR CERTAIN
PROFESSIONAL SERVICES ADOPTED BY THE BOROUGH OF
CLAYTON**

WHEREAS, there exists a need for specialized services on behalf of the Borough of Clayton; and

WHEREAS, funds are or will be available for this purpose; and

WHEREAS, the Local Public Contracts Law, N.J.S.A. 40A:11-1 requires that notice with respect to contracts for Professional Services awarded without competitive bids must be publicly advertised.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Clayton, County of Gloucester, and State of New Jersey as follows:

1. That Environmental Resolutions, Inc., of Mount Laurel, New Jersey is hereby hired to provide environmental activities associated with the Clayton Water Yard for a total amount not to exceed \$12,000.00.
2. The term of this contract shall be from February 28, 2019 to February 27, 2020.
3. Donna Nestore, CFO, for the Borough of Clayton certifies that \$12,000.00 is available through the 2019 Municipal Budget, Environmental Engineering O&E.
4. The Contract is awarded without competitive bidding as a "Professional Service" in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-11-5(1)(a), and the Fair and Open Process because it is for services performed by persons authorized by law to practice a recognized profession.
5. A copy of this resolution as well as the Contract shall be placed on file with the Clerk of the Borough of Clayton.
6. A notice in accordance with the Local Public Contracts Law of New Jersey shall be published in The Sentinel or South Jersey Times.
7. The Mayor and Clerk of the Borough of Clayton are hereby authorized to execute a Contract outlining the above on behalf of the Borough of Clayton.

Task 4. Remediation Observation/Post Remediation Soil Sampling

Estimated Fee - \$5,000.00

ERI will provide contractor oversight during remediation activities, to ensure all impacted areas are adequately addressed through removal of lead contaminated soil. Upon removal of lead contaminated soil, ERI will collect up to ten (10) post excavation soil samples to document the successful removal of lead contaminated soil. Upon confirmation that all impacted soil has been removed, ERI will oversee the backfilling of the excavation with certified cleanfill. ERI anticipates oversight will take one (1) day and one (1) day for backfilling.


All soil samples will be submitted for "Expedited" turn around time for results, with results requested within 48 hours of submittal of samples to the laboratory.
