RESOLUTION AUTHORIZING AGREEMENT FOR CERTAIN PROFESSIONAL SERVICES ADOPTED BY THE BOROUGH OF CLAYTON

- 1. That Sickels & Associates, Inc., of Woodbury, New Jersey is hereby hired to provide surveying and engineering and construction management services for the Costill Avenue / N. Dennis Drive Drainage Project for a total amount not to exceed \$14,200.00.
- 2. The term of this contract shall be from April 11, 2019 to April 10, 2020.
- 3. Donna Nestore, CFO, for the Borough of Clayton certifies that \$14,200.00 is available through the 2019 Municipal Budget. Engineering O&E.
- 4. The Contract is awarded without competitive bidding as a "Professional Service" in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-11-5(1)(a), and the Fair and Open Process because it is for services performed by persons authorized by law to practice a recognized profession.
- 5. A copy of this resolution as well as the Contract shall be placed on file with the Clerk of the Borough of Clayton.
- 6. A notice in accordance with the Local Public Contracts Law of New Jersey shall be published in <u>The Sentinel or South Jersey Times</u>.
- 7. The Mayor and Clerk of the Borough of Clayton are hereby authorized to execute a Contract outlining the above on behalf of the Borough of Clayton.

Sickels & Associates, Inc. would like to thank you for the opportunity to offer this proposal for surveying, engineering and construction management services in connection with the above referenced project.

It is our understanding that the Borough wishes to proceed with drainage improvements at the intersection of Costill Avenue and North Dennis Drive. We understand the work will be funded through a CDBG grant and the Borough staff will complete the construction tasks. The work will include installation of a new drainage system to collect and transport stormwater runoff. Our scope of work will include survey field work, stormwater extension plans and details to address construction requirements.

We understand the County did not provide the full funding requested in the Borough's Application. Our office will complete the full design for the project to allow the Borough staff to complete as much work as possible.

The scope of work will include connection to the existing 24" storm pipe on Costill Avenue, extending new storm pipe to N. Dennis Drive, and verifying the underground utility locations at the intersection of the aforementioned streets.

Based upon the existing condition plan, utilities and services location, determine a route for the new storm sewer on N. Dennis Drive to Smith Street. Prepare plan and profile with available utility information to show construction issues for Borough staff's use in field.

We have prepared the following proposal for the various surveying, engineering and inspection services that we anticipate will be required on the above referenced project. Said services are based upon Sickels & Associates, Inc.'s understanding of the project as described above.

For ease of review, the proposal is organized in the following manner; Our Understanding of the Project, Description of Services, Consulting Fee and Terms and Conditions.

OUR UNDERSTANDING OF THE PROJECT

Our approach to this project as outlined in the Description of Services consists of the following two (2) phases.

PHASE I Topographical Survey & Base Plan Preparation

PHASE II Storm Sewer Extension Plans

PHASE III Construction Management Services

For the purpose of defining the extent of services which may be required for completion of the surveying, engineering and design of this project, this proposal assumes that all necessary construction will be performed by the Clayton Public Works Department. As such, contract documents and technical specifications required for public bidding purposes are not included within this scope of approval.

Our proposal does not include performing test pits to verify locations of utilities and services, nor does it include a soil investigation program to identify subsurface soil conditions and groundwater levels. Sickels & Associates, Inc. will provide a proposal if such services are deemed necessary.

DESCRIPTION OF SERVICES:

Based on the above project description, our scope of services will include the following activities:

PHASE I TOPOGRAPHICAL SURVEY & BASE PLAN

SECTION 1.0 AVAILABLE INFORMATION

- 1.1 Request and obtain available information from Municipal agencies such as as-built plans and tax maps for use in preparing base plans.
- 1.2 Call for utility markout of area in question prior to initiation of field work. We will request the Clayton Water & Sewer Department to field mark out the existing water and sewer mains, force main and services.
- 1.3 Our office will forward a copy of the base field plan to SJ Gas to obtain their markout of the gas mains.

SECTION 2.0 TOPOGRAPHIC SURVEY

- 2.1 Establish horizontal and vertical ground controls for survey of the project area by establishing two GPS points along the project. Provide a minimum of two (2) bench marks for the construction purposes.
- 2.2 Establish approximate location of right-of-way and property boundaries within and adjacent to the project area based upon available tax map information. Monumentation, if present, will be field located and identified but will not be verified since the storm pipe will be installed in the roadway or sidewalk area.
- 2.3 Obtain topographic information by field survey to locate and identify pertinent features within and immediately adjacent to the right-of-way, where required.
- Obtain spot elevations at fifty (50) foot intervals on tangent length of road and 25' section on curves to define the profile of the existing centerline, curb line, gutter line, sidewalk and right-of-way.
- 2.5 Investigate and identify by field survey the location, elevation, size and type of all visible and/or accessible utilities, water mains, sanitary and storm drainage facilities within the project limits. Verify depths of sewer cleanouts and water curbstops where Borough staff have made them accessible.

SECTION 3.0 PREPARATION OF BASE PLANS

- 3.1 Prepare base plans using Auto CAD Software showing the overall project limits, Right-of-Way and property line locations and elevations to develop plans and profiles.
- 3.2 The plans and profiles shall be prepared at a minimum scale of 1" = 20' (horizontal scale) and 1" = 2' (vertical scale).
- 3.3 Submit utility base plans to respective Municipal and Utility agencies for review and verification of information shown thereon.

PHASE II STORMWATER EXTENSION PLANS

The scope of this Phase includes preparation of construction and technical documents.

SECTION 1.0 CONSTRUCTION DESIGN

- 1.1 Obtain current information such as lot and block designations, names and addresses of property owners.
- 1.2 Prepare stormwater inlet on manhole locations to collect the stormwater runoff. The system will connect to the existing stormwater system at N. Dennis Drive and Smith Street.
- 1.3 Verify potential conflicts with existing underground utilities. Determine route of storm pipes and verify sufficient depth/cover with road and existing utilities.
- 1.4 Upon completion of the base plans in Phase I, determine the proposed stormwater collection system along Costill Ave. and N. Dennis Dr.
- 1.5 Coordinate with your office for the means to collect sump pump discharges.

 Add that information to construction plans.
- 1.6 Design details for proposed stormwater installation.
- 1.7 Design soil erosion and sediment control measures and prepare necessary narrative for basic site construction issues.
- 1.8 Forward draft plan to your office for review and comment.
- 1.9 Review comments with your office and make final edits to construction plans.
- 1.10 Forward five (5) sets of plans to your office for your use.

PHASE III CONSTRUCTION MANAGEMENT

The project will involve inspecting the Borough's pipe installation, sidewalk and pavement improvements for the areas constructed.

- Our staff will meet with the Public Works Dept. staff at the site to verify the storm pipe, pavement, sidewalk and handicap improvements have been installed in compliance with the Borough and Federal ADA requirements. Any discrepancies will be reviewed with the Borough staff so they can be addressed. Follow up inspections will be scheduled accordingly.
- 1.2 Our office will also complete the necessary paper work with the County to document the construction work. We will also coordinate with the Borough Finance office to submit closeout documentation to the County.
