Pursuant to the request made by the Applicant, we have completed our review of the above referenced site to determine if the performance bond (\$315,594.00 reduced amount) can be released for the above referenced project. Based on the findings of our observations, we are informing the Borough that the work under this project has been completed, corrected and/or repaired.

As such, we would recommend that Borough consider the release of the performance bond contingent upon the posting of the required maintenance bond in the amount of \$131,497.50 and an additional \$2,500.00 to be deposited into the escrow account to cover the release of the maintenance bond. The maintenance bond should provide coverage for the two (2) year period from the date the site-received acceptance of the site improvements. Therefore, the maintenance bond expiration date is August 9, 2021.

It should be noted that prior to the release of the performance bond, all outstanding engineering fees must be paid in full.
