**WHEREAS**, Thomas Bianco, the Mayor of the Borough of Clayton for the calendar year of 2014; and

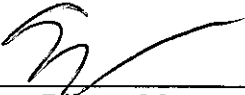
**WHEREAS**, Christine Newcomb the Municipal Clerk of the Borough of Clayton for the calendar year of 2014.

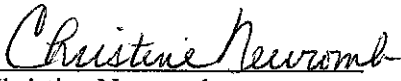
