**RESOLUTION OF THE BOROUGH OF CLAYTON AUTHORIZING THE "PERSON  
TO PERSON" AND "PLACE TO PLACE" TRANSFER OF PLENARY RETAIL  
DISTRIBUTION LICENSE NO. 08-01-44-007-001 ISSUED BY THE BOROUGH  
OF CLAYTON FROM HETALBEN R. PATEL TO "1007 RADHAKRISHNA, LLC"**

**WHEREAS**, applications have been filed for person-to-person and place-to-place transfers of plenary retail distribution License No. 08-01-44-007-001, heretofore issued to Hetalben R. Patel., 120 Willow Oak Lane, Mullica Hill, New Jersey; and

**WHEREAS**, submitted application forms are complete in all respects, the transfer fees have been paid, and the license has been properly renewed for the current license term, and

**WHEREAS**, the applicant is qualified to be licensed according to all standards established by Title 33 of the New Jersey Statutes, regulations promulgated thereunder, as well as pertinent local ordinances and conditions consistent with Title 33; and

**WHEREAS**, the applicant has disclosed and the issuing authority reviewed the source of all funds used in the purchase of the license and the licensed business and all additional financing obtained in connection with the license business; and

**WHEREAS**, the Borough Council having further determined that no written objections to the transfers have been received; and

**WHEREAS**, the Borough Council has conducted a thorough investigation in this matter as required by NJAC 13:2-7.7,

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Borough Council of the Borough of Clayton that effective January 15, 2015 they hereby approve the transfers of the aforesaid plenary retail distribution license from Hetalben R. Patel and they hereby direct the Municipal Clerk to endorse the license certificate to the new ownership as follows: "This license, subject to all its terms and conditions, is hereby transferred to 1007 Radhakrishna, LLC, 414 South Delsea Drive, Clayton, New Jersey, effective January 15, 2015.

**BE IT FURTHER RESOLVED** that a copy of this Resolution, duly certified be forwarded to the Alcoholic Beverage Commission of the State of New Jersey.
