

**RESOLUTION 202-14**

**AWARDING CONTRACT FOR WIRELESS  
(RF) AUTOMATICALLY READ WATER METERS WITH METER  
COUPLINGS AND GASKETS**

**WHEREAS**, the Borough of Clayton desires to purchase One Hundred Seventy Five (175) 5/8 inch by 3/4 inch T-10 Wireless (RF) Automatically Read Water Meters with Meter Couplings and Gaskets, Two (2) 1" T-10 Wireless (RF) Automatically Read Water Meters with Meter Couplings and Gaskets, Two (2) 2" Flanged meters, Two (2) 2" T-10 Wireless (RF), and Two (2) Hydrant Meters; and

**WHEREAS**, RIO Supply, Inc., of Sicklerville, NJ has submitted the lowest responsible bid of \$52,925.00; and

**WHEREAS**, a Certification has been issued by the Chief Financial Officer of the Borough of Clayton, certifying that funding is available through an appropriation in the 2014 Water and Sewer Budget.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Clayton, County of Gloucester and State of New Jersey that a contract be and is hereby awarded to RIO Supply, Inc. of Sicklerville, NJ for the purchase of One Hundred Seventy Five (175) 5/8 inch by 3/4 inch T-10 Wireless (RF) Automatically Read Water Meters with Meter Couplings and Gaskets, Two (2) 1" T-10 Wireless (RF) Automatically Read Water Meters with Meter Couplings and Gaskets, Two (2) 2" Flanged meters, Two (2) 2" T-10 Wireless (RF), and Two (2) Hydrant Meters, pursuant to the specifications of the Borough of Clayton and the bid submitted.

**BE IT FURTHER RESOLVED** that the Water and Sewer Department is authorized to issue a purchase order/voucher to RIO Supply, Inc. of Sicklerville, NJ.


