**Resolution Authorizing Governor's Council on Alcoholism and Drug Abuse
Fiscal Grant Cycle July 2014-June 2019**

WHERE AS, the Governor's Council on Alcoholism and Drug Abuse established the Municipal Alliances for the Prevention of Alcoholism and Drug Abuse in 1989 to educate and engage residents, local government and law enforcement officials, schools, non-profit organizations, the faith community, parents, youth and other allies in efforts to prevent alcoholism and drug abuse in communities throughout New Jersey.


