## RESOLUTION BOROUGH OF CLAYTON APPOINTING JOHN ALICE, ESQUIRE AS CONFLICT SOLICITOR FOR THE BOROUGH OF CLAYTON FOR THE YEAR 2014, PURSUANT TO THE LOCAL PUBLIC CONTRACTS LAW

(N.J.S.A. 40A:11-1, ET SEQ.)

WHEREAS, there exists a need for a Conflict Solicitor in the Borough of Clayton for the purpose of providing the Borough with legal services and advice; and

WHEREAS, funds are or will be available for this purpose; and

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) requires the governing body of a contracting unit to public a notice in a newspaper authorized by law to publish its legal advertisements, setting forth the nature, duration, service and amount of the contract where such contract is awarded for "professional services" without competitive bidding;

**NOW, THEREFORE, BE IT RESOLVED,** by the Mayor and Council of the Borough of Clayton as follows:

- 1. That John Alice, Esquire, be hereby appointed as Conflict Solicitor for the Borough of Clayton, to provide services and advice to the officials of said Borough for the year 2014.
- 2. That the appropriate officers of the Borough of Clayton are hereby authorized to enter into the contract with the firm of John Alice, Esquire, for legal services above specified, for a term of one (1) year, commencing January 23, 2014, and to be paid in accordance with the 2014 budget.
- 3. This contract is awarded without competitive bidding as a "professional service" under the provision of the Local Public Contracts Law because the specialized training, education, experience and specialized knowledge needed for this position cannot be properly described in specifications which would have to be prepared for competitive bidding, and

because the law permits agreements for professional services without public advertising and bidding therefore.

4. A notice of the award of this contract shall forthwith be printed once in The Sentinel or Gloucester County Times, the official newspaper of the Borough of Clayton, authorized by law to publish the legal advertisements of the Borough of Clayton, setting forth the nature, duration, service and amount of the contract, and further stating that this resolution and the annexed contract are on file and available for public inspection in the Office of the Clerk of the Borough of Clayton.
