**AMENDMENT TO AN AGREEMENT
BETWEEN
COUNTY OF GLOUCESTER
AND
BOROUGH OF CLAYTON**

THIS is an amendment to an agreement entered into on the 28th day of February 2013, by and between the County of Gloucester and the Borough of Clayton.

In further consideration for the mutual promises made by and between Grantee and County in the above-described agreement, Grantee and County hereby agree to amend the agreement as follows:

The Agreement is amended for additional agreement specified for Prevention Programs to benefit Gloucester County Residents. The reason for the amendment is the State converted from a calendar year to a fiscal year. This amendment will increase the maximum agreement amount by \$5,061.00, resulting in a maximum agreement amount of \$15,183.00 and extend the term through June 30, 2014.

Whereas, a Certificate of Availability of Funds has not been issued at this time, and prior to any purchase being made or services being rendered pursuant to the within agreement, a Certificate of Availability shall be obtained from the Treasurer of the County of Gloucester certifying that sufficient monies are available at that time for that particular purpose, and identifying the line item from the County budget from which said funds will be paid.

All other terms and provisions of the agreement and conditions set forth therein that are consistent with the Addendum and State requirements, shall remain in full force and effect.

THIS ADDENDUM is effective as of the 20th day of February, 2014.
