**RESOLUTION AWARDING CONTRACT FOR THE

WHEREAS, there is a need to purchase Body Worn Cameras for the Police Department of the Borough of Clayton, County of Gloucester, State of New Jersey; and

WHEREAS, this can be purchased through State Contract #A81311, and

WHEREAS, the amount of the purchase price is \$13,176.10 for the Police Department Body Worn Cameras.

WHEREAS, a Certification has been issued by the Chief Financial Officer of the Borough of Clayton dated May 26, 2016 certifying that sufficient funds have been appropriated and are available to cover this contract. WHEREAS, public bids are not required when the purchase is under a state contract in accordance with 40A:11-12 of the Local Public Contracts Law.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Clayton, that L3 Mobile Vision Inc. of Rockaway, New Jersey, be and hereby is awarded the Contract for the purchase of Police Department Body Worn Cameras for a total amount of \$13,176.10 and in accordance with the terms and conditions set forth in the specifications promulgated by the Borough of Clayton; and

BE IT FURTHER RESOLVED that the Mayor and Clerk be and hereby are authorized to execute said Contract.
