RESOLUTION AUTHORIZING RELEASE OF PERFORMANCE BOND (ABERDEEN PHASE I, ATHLETIC FIELDS) FOR HOVBROS CLAYTON, LLC UPON THE POSTING OF A MAINTENANCE BOND

WHEREAS, the applicant, HovBros Clayton, LLC – Athletic Fields (a.k.a. Academy Walk –I), has posted, pursuant to the requirements of the Clayton Development Regulation and Zoning Ordinance, Performance Guarantees, guaranteeing the site improvements in conjunction with said improvement; and

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Clayton, in the County of Gloucester and State of New Jersey, that the aforementioned performance guarantees for HovBros Clayton LLC (Aberdeen Phase I – Athletic Fields) be and hereby is released upon the posting of a two (2) year

maintenance bond as per the Engineers letter with a maintenance guarantee in the amount of \$35,393.13 for site improvements.

BE IT FURTHER RESOLVED that any and all outstanding engineering, escrow and/or legal fees, if any, shall be paid in full.

Dear Mayor and Council Members:

Pursuant to the request made by the Applicant letter dated March 17, 2016, we have completed our review of the above referenced site to determine if the Performance Bond can be released for the above referenced property. Based on the findings of our observations, we are informing the Borough that the majority of the work under this project has been completed, corrected and/or repaired.

The Borough of Clayton requires that the Applicant post a Maintenance Bond in the amount of 15% of the original Performance Bond for a period of two (2) years. The amount of the Bond is as follows:

	Maintenance Bond Amount (15%)
\$117,977,10	\$35,393.13

As such, we would recommend that Borough consider the release of the Performance Bond contingent upon the posting of the required Maintenance Bond in the amount of \$35,393.13 and an additional \$750.00 to be deposited into the escrow account to cover the release of the Maintenance Bond. The Maintenance Bond should provide coverage for the two (2) year period from the date the site-received acceptance of the site improvements. Therefore, the Maintenance Bond expiration date is October 28, 2017. It should be noted that prior to the release of the Performance Bond, all outstanding engineering fees must be paid in full and the Maintenance Bond should be submitted to the Borough Solicitor for his review and approval. By copy of this letter to Christine Newcomb, Borough Clerk, we are requesting that this matter be placed on the agenda for approval at the next available Mayor & Council meeting.
