The Gloucester County Prosecutor's Office has approved you request for participation in the 2016 Click it or Ticket Campaign. All paperwork must be submitted by June 10, 2016. Failure to submit the required paperwork may result in non-reimbursement of your overtime. All necessary paperwork is attached.
