RESOLUTION PROVIDING FOR THE INSERTION OF
A SPECIAL ITEM OF REVENUE IN THE BUDGET
PURSUANT TO N.J.S.A. 40A:4-87

BOROUGH OF CLAYTON, COUNTY OF GLOUCESTER

WHEREAS, N.J.S.A. 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the budget when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget; and

WHEREAS, the Director may also approve the insertion of an item of appropriation for equal amount;

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Borough Council of the Borough of Clayton in the County of Gloucester, New Jersey, hereby requests the Director of the Division of Local Government Services to approve the insertion of an item of revenue in the budget of the year 2016 in the sum of \$1,400.00, which is now available as a revenue from the County of Gloucester pursuant to the provisions of statute.

BE IT FURTHER RESOLVED that the like sum of \$1,400.00 is hereby appropriated under the caption 2016 Click it or Ticket Campaign; and


BE IT FURTHER RESOLVED that a certified copy of the required certification, together with supporting documentation, be filed in the office of the Director of Local Government Service for certification.



Sgt. Dick,

The Gloucester County Prosecutor's Office has approved you request for participation in the 2016 Click it or Ticket Campaign. Funding amounts were reduced for all departments in order to accommodate more agencies participating. You are approved for \$1,400 in overtime salary. Acceptance of this funding is contingent on the following:

1. Pay rate is \$50 per hour, for 4 hour blocks (any additional overage is covered by your departmental overtime).
2. Details are to be conducted between May 23, 2016 and June 5, 2016.
3. 25% of your patrols (2 details) must be conducted during the hours of 8pm - midnight.
4. All officers must complete the attached daily activity report. The report must be signed by the officer and his/her supervisor (cannot be signed twice by the same person, and must be signed - no printed signatures).
5. Your agency must complete and return the enforcement summary report with the total statistics for the mobilization from your agency.
6. The following financial paperwork must be submitted: Expenditure summary, salary detail form, payment voucher, and payroll certification. These forms must be signed by your CFO/Treasurer.
7. The Division of Highway Safety is also implementing performance standards for this mobilization. Failure to meet these standards may result in exclusion from future funding. Please see the attached document for further details.

All paperwork must be submitted by June 10, 2016. Failure to submit the required paperwork may result in non-reimbursement of your overtime. All necessary paperwork is attached.
