WHEREAS, the amount of the purchase price is \$9,789.56 for the Police Department Ammo; and

WHEREAS, a Certification has been issued by the Chief Financial Officer of the Borough of Clayton dated June 8, 2017 certifying that sufficient funds have been appropriated and are available to cover this contract.
