PROGRAM NARRATIVE

PROGRAM TITLE: Clayton Night Out / Police Chaplain / Coffee with A Cop APPLICANT AGENCY: Borough of Clayton - Clayton Police Department

a. Identified Need (25 Points). Please identify and describe the specific need for the proposed community policing program in your community, the target population to be served, the number of citizens who will receive or participate in services, and the geographic area that your proposed program will impact.

Clayton Night Out: The citizens of the Borough of Clayton want and need to get to know the men and women who serve in their community as police officers. They wish to know what the issues are that are facing their community and what the police department is doing to address these problems. It also gives the citizens a chance to meet like minded neighbors and learn how to empower themselves through community organizations such as the Clayton Crime Watch which helps enhance police services. The event is family friendly and helps open a dialogue between citizens and police. This event targets all of the citizens of Clayton, approximately 8,500. We are expecting about 100 - 200 participants this year.

Police Chaplain Program: The Clayton Police Chaplain Program is in the process of being created. In today's age a Chaplain Program is essential for a community. The program will encompass any citizen that comes into contact with a Clayton Police Officer and agrees to a chaplain's aid. Police are very good at handling highly stressful critical incidents, and are also very empathic towards citizens. The problem occurs in time management because police officers duties do not afford them the time to comfort a grieving family member, or to combat the underlying debilitating effects of alcoholism, drug dependency, domestic violence, etc... In steps the Police Chaplain who will be especially trained to show compassion and to help address these debilitating factors. The Chaplains have access to many resources that address these problems. They may be able to provide assistance to get them back on track to being happy, healthy, law abiding citizens. In addition, Chaplains are also respected pillars of the community. In the event that any civil disturbance arises the police chaplains can be called on to quell any riotous behavior. In a press conference their mere presence supporting the police department could swing public opinion to a positive for police. The Chaplains would also be an asset to the rank and file officers. They would be afforded the opportunity to speak / have ride-alongs / meet with chaplains where they could discuss managing their stress.

Coffee with A Cop: This Program targets anyone that visits the coffee establishment chosen for the event. The Clayton Police have conducted previous coffee with a cop events where hundreds of citizens were able to speak with police in a non threatening environment. The need for these type of events are essential in keeping an open dialogue with the members of the public.

Police Trading Card Program: The Police Trading Card Program can be used during any police/citizen contact specifically geared towards younger citizens and collectors of all ages. The cards will help introduce officers and give a brief biography of who they are.

b. Program Design and Implementation (55 Points). Please explain your proposed community policing program in detail and indicate how it will address the identified need. Clayton Night Out Event: The Clayton Police Department will hold a "National Night Out Event" on Tuesday August 1st, 2017. The event is open to all citizens in the area (Clayton Population is 8,500 citizens) We meet with citizens in a town park where we discuss recent crime trends, what the police department has done to address these problems. We then break the citizens into smaller groups to perform a 30 minute foot patrol with a uniformed police officer. It is at this time that citizens can discuss ideas, concerns, and just get the opportunity to talk with a police officer on a personal level. The police officer will share past work experiences with the citizens so they learn a little about what we do day in and day out. This is a highly visible community policing tool that shows that there is "Unity in the Community". After the crime walk is complete all participants meet back at the park where they are treated to refreshment provided by local business. There are also numerous prizes raffled off as well as free giveaways (T-Shirts, pens, coffee mugs, beach balls, etc...) We expect approximately 100 participants in this years event. This event also incorporates the Clayton Crime Watch Meeting for the Month of August. The Grant Money requested will pay for 4 police officers to work the event.

Clayton Police Chaplain Program: This program will target the entire Borough of Clayton (8,500 citizens). This program is just being initiated. The Clayton Chief of Police has spoken to various houses of faith leaders, citizens, politicos, and members of the police force. All members of the community have been in huge support of the program. The largest obstacle has been finding the funding to initiate the program. I am estimating that approximately 10 - 12 faith leaders will wish to become Police Chaplain. The Chaplain will be used in various roles. The can assist both citizens and police officers in managing stress and critical incidents. They can assist in Death Notifications, Suicide Incidents, Domestic Violence, Station House Adjustments for Juvenile Offenders, and anytime a citizen or officer requests a Chaplain. In addition they would be a priceless asset to have in a time of civil disorder or to stand with the police department during a press conference in which Sensitivity or Diversity has became an issue. The Chief of Police hopes to have this program's first meeting in August/September 2017. The money from the grant would be used to purchase Chaplain's Uniform and Training.

Coffee With A Cop Program: This is an ongoing community policing program that would touch any citizens who visits the Coffee Establishment where the event is occurring. It gives the citizens an opportunity to meet with a police officer on a personal level and discuss what ever is on his mind. In past events we have spoken to hundreds of people. If kids and parents speak with the police we wish to be able to give them a T-shirt that has already been designed with a cool logo and states "I had Coffee with a Clayton Cop Today". We have not been able to obtain funding for the shirts but hope to do so through this grant. The Clayton Police Department has conducted these events periodically usually 2-3 times a year. The grant would be used to purchase T-Shirts to be given to citizens who participate to foster good will among the community. Note: Off Duty Police Officers donate their time for this program.

Police Trading Card Program: Will be used as a fun way to introduce officers to citizens can be used as an "Ice Breaker" when initiating conversations with citizens. Will be distributed during the grant period. All full time officers will be given 250 Cards to hand out during community events and during normal patrol functions.

c. Partnership, Collaboration, and Coordination (15 Points). Partnerships, collaborations, and coordination with community members and groups are strongly encouraged. Describe what community organizations, groups, or individuals were consulted and/or will be involved with the proposed program and their level of involvement. Clayton Night Out: Clayton Night Out is truly a community wide event that encompasses partnerships, collaboration and coordination from multiple organizations. The Clayton Police Department is obviously the primary organization represented. All of our food (Pizza) Soda, Water, Paper Products, Desserts, raffle items, etc... are donated from local business. The businesses are recognized during the event for their donations. In addition, the Clayton Fire Department, Gloucester County Prosecutors Office, and Gloucester County EMS send representatives. The 3rd legislative district along with Borough Mayor and Council attend the event. The Clayton Crime Watch August meeting is replaced with participation in the event. Clayton Special Events Committee post notices to the public. Many houses of worship attend the event along with the Boy Scouts of America.

Chaplain Program: The Chaplain Program foundation is a partnership/collaboration between the specific house of worship and the police department. The Chief of Police estimate that all houses of worship in the Borough of Clayton will have at least some involvement with the program whether it be simply receiving emails or attending periodic meetings. The Chief estimates that approximately 10 - 12 Chaplains will volunteer their service to the program.

Coffee with A Cop: The police department partners with local business that sell coffee (may expand to ice cream with a cop during summer months). The business usually gives coffee for free or at discounted price to all participants. The event not only strengthens ties between police and citizens but also local business.

Police Trading Card Program: The Trading Card Program can be used to enhance any community event. They can be left and displayed in local businesses, houses of worship, municipal building, etc...

d. Background, Experience, and Capability; Project Management and Staff (5 Points). Please describe your police department's background and experience (if any) with police community programs, and your department's knowledge and capability to carry out the proposed program. The Clayton Police Department is community policing oriented. We currently support a Town Crime Watch Program which meets monthly where we educate citizens of crime trends and what they can do to protect themselves and work with the police. We participate in National Night Out which is described in Section B of this Grant. We conduct Coffee with a Cop details of which can be reviewed in Section B of this Grant. Clayton Police joined Law Enforcement Officers Against Drugs (L.E.A.D.) in which we are teaching school age children skills to succeed in life in many different areas including drug resistance, violence education, bullying, peer pressure, etc.. We also supported Hidden in Plain Sight, a program where family members of school age children can be educated in what to look for to see if children are involved with drug abuse. Clayton Police, in conjunction with an Emergency Room Doctor, and County Freeholder Dan Christy spoke to students about dangerous of making bad decisions (focusing on drugs and alcohol) in a Pre-Prom assembly, a mock accident scene was recreated in which the school drama club acted out the part of an intoxicated student driver which killed classmates and was subsequently arrested. The Clayton Police also has a role in many community events such as "Movie in the Park", "Clayton Day", Borough Parades, School Graduation, Sporting Events, participation in local charity events which benefit local kids with financial needs to pay for medical bills, Toys for Tots Program during Christmas, just to name a few.

Chief Andrew Davis is the police department head and was the Community Policing Officer before being promoted to his current position. Chief Davis has expanded on a number of community policing programs already in existence and is currently in the process of implementing the Police Chaplain Program. Ptlm. Edward Hyder has taken over the role of Community Policing Officer and has improved many existing programs with fresh idea which has made them even more successful. As part of each and everyone of Clayton Police Officers job description they are expected and have in some capacity participated in community policing almost everyday.

The Clayton Police Department has the experience, knowledge and desire to improve on the above listed community events, it is the hope that this grant be awarded to the Clayton Police Department so that we have the financial means to create the Chaplain Program, improve on the Coffee with a Cop Program, and help to alleviate the financial burden that arises from paying for the Clayton Night Out Program. The Police Trading Card Program will allow for a fun way to start conversations with citizens and will be able to have a name, face, and brief background of the officers that work in their town.
