RESOLUTION PROVIDING FOR THE INSERTION OF
A SPECIAL ITEM OF REVENUE IN THE BUDGET
PURSUANT TO N.J.S.A. 40A:4-87

BOROUGH OF CLAYTON, COUNTY OF GLOUCESTER

WHEREAS, N.J.S.A. 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the budget when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget; and

WHEREAS, the Director may also approve the insertion of an item of appropriation for equal amount;

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Borough Council of the Borough of Clayton in the County of Gloucester, New Jersey, hereby requests the Director of the Division of Local Government Services to approve the insertion of an item of revenue in the budget of the year 2017 in the sum of \$1,760.00, which is now available as a revenue from the 2017 Labor Day Drive Sober or Get Pulled Over DWI Saturation Campaign pursuant to the provisions of statute.

BE IT FURTHER RESOLVED that the like sum of \$1,760.00 is hereby appropriated under the caption 2017 Labor Day Drive Sober or Get Pulled Over DWI Saturation Campaign; and


BE IT FURTHER RESOLVED that a certified copy of the required certification, together with supporting documentation, be filed in the office of the Director of Local Government Service for certification.

Sgt. Dick,

The Gloucester County Prosecutor's Office has approved your request for participation in the 2017 Labor Day Drive Sober or Get Pulled Over DWI Saturation Patrol Campaign.

Please carefully review the conditions of the grant funding listed below. All conditions must be met in order to receive reimbursement. Please advise your officers that if they are a supervisor, they CANNOT sign and review their own daily activity report, it must have two different signatures on it. Pay particular attention to the dates of the grant period, any details worked outside of these dates will result in that reimbursement being deducted from your total reimbursement.

You are approved for \$1,760 (8 shifts) in overtime salary. Acceptance of this funding is contingent on the following:

1. Pay rate is \$55 per hour, for 4 hour blocks (any additional overage is covered by your DDEF funding). PLEASE REVIEW YOUR FUNDING AMOUNT THAT YOU WERE APPROVED FOR ABOVE
2. Details are to be conducted between August 18, 2017 and September 4, 2017.
3. All officers must complete the attached daily activity report. The report must be signed by the officer and his/her supervisor (CANNOT BE SIGNED TWICE BY THE SAME PERSON - MUST BE ACTUAL SIGNATURES - PRINTED NAMES WILL NOT BE ACCEPTED).
4. Your agency must complete and return the enforcement summary report with the total statistics for the mobilization from your agency.
5. The following financial paperwork must be submitted: Expenditure summary, salary detail form, payment voucher, and payroll certification. These forms must be signed by your CFO/Treasurer.
6. Please review the attached Performance Standards. While failure to meet these standards may not exclude you from reimbursement, they may jeopardize future funding for your department.

All paperwork must be immediately submitted upon completion of the grant period. Failure to submit the required paperwork may result in non-reimbursement of your overtime. This grant closes on September 30, 2017, and all necessary paperwork must be submitted by our office by that date; therefore all documentation must be submitted to me no later than September 25, 2017, or you will not receive reimbursement. All necessary paperwork is attached. Please disregard all previous forms and use the ones that are attached. They have been updated.
