RESOLUTION AUTHORIZING RELEASE OF PERFORMANCE BOND (WATER AND SEWER IMPROVEMENTS) FOR 4U CORPORATION – 7TH STREET, BLOCK 1817, LOTS 4 & 5 UPON THE POSTING OF A MAINTENANCE BOND

WHEREAS, the applicant, 4U Corporation – Water and Sewer Improvements (7th Street – Block 1817, Lots 4 & 5), has posted, pursuant to the requirements of the Clayton Development Regulation and Zoning Ordinance, Performance Guarantees, guaranteeing the water and sewer improvements in conjunction with said project; and

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Clayton, in the County of Gloucester and State of New Jersey, that the aforementioned performance guarantees for 4U Corporation (7th Street – Block 1817, Lots 4 & 5) be and hereby is released upon the posting of a two (2) year maintenance

bond as per the Engineers letter with a maintenance guarantee in the amount of \$3,931.20 for water and sewer improvements.

BE IT FURTHER RESOLVED that any and all outstanding engineering, escrow and/or legal fees, if any, shall be paid in full.
