RESOLUTION AWARDING CONTRACT FOR THE PURCHASE OF BERETTA CARBINE RIFLES AND ACCESSORIES FOR THE POLICE DEPARTMENT

WHEREAS, there is a need to purchase Beretta Carbine Rifles and accessories for the Police Department for the Borough of Clayton, County of Gloucester, State of New Jersey; and

WHEREAS, the amount of the purchase price is \$5,165.00 for the Police Department Rifles and accessories; and

WHEREAS, a Certification has been issued by the Chief Financial Officer of the Borough of Clayton dated January 26, 2017 certifying that sufficient funds have been appropriated and are available to cover this contract. 
WHEREAS, public bids are not required when the purchase is under a state contract in accordance with 40A:11-12 of the Local Public Contracts Law.


