Environmental Resolutions Inc. (ERI) is pleased to submit this proposal for the preparation of an Area of Concern Site Investigation/Remedial Investigation/Remedial Action Report for the above referenced site.

Task 1: Preparation of Area of Concern Specific Site Investigation/Remedial Investigation/Remedial Action Report

In accordance with the New Jersey Department of Environmental Protection (NJDEP) Technical Guidance Document NJAC 7:26E, ERI will prepare an Area of Concern Site Investigation/Remedial Investigation/Remedial Action Report (report) for the former Wayne's Auto Site. ERI is recommending the required reports be prepared, combined and submitted at this time. Since seven (7) of the eight (8) Areas of Concern have been remediated to the unrestricted use standards set forth by the NJDEP, no additional remedial investigations or remedial actions are necessary for them and the additional required reporting can be done at this time. The purpose of combining these reports is to advance the site through the required reporting process.

The report will document all the sampling and remediation activities conducted in conjunction with Areas of Concern identified in the 2016 Preliminary Assessment prepared by T&M Associates. Note that the Preliminary Assessment will be an appendix to the report.

ERI will prepare maps, tables and data from all the sampling events, identify any potential receptors that may have been impacted, describe the remediation of contamination as appropriate and provide recommendations for the area of concern that have not been remediated to date (i.e. Area of Concern 8 – Historically Applied Pesticides). Upon completion of remediation for this Area of Concern, a separate cost proposal will be submitted for the preparation of a Remedial Investigation/Remedial Action Report.

ERI will be able to complete the preparation of the report and submit same to the NJDEP, in approximately 45-60 days after authorization.

ERI will conduct this activity for a fee of

\$8,000.00

These fees are included in the funds made available to the Borough by the NJDEP Hazardous Site Remediation Fund. The Borough has previously received these funds.

No other activities will be included in this proposal. All terms and conditions of ERI's contractual agreement with the Borough of Clayton are in effect.
